## TERMS AND CONDITIONS

The Club offers non-proprietary memberships for its Clubs.

## CONDITIONS OF MEMBERSHIP

The Body and Soul Health Clubs have the right to accept members at its sole discretion.

Prospective members will be required to submit an application form and complete all the details.

Full membership shall be for the period of one year or six month's dated from the date of joining. Other membership terms and categories may be introduced from time to time at the discretion of the Club. Membership cannot be cancelled and refunds for membership will not be applicable unless granted at the sole discretion of the Club. The membership is not transferable to another name and cannot be frozen

• Membership fee paid includes 25% Administration Fees. In case of membership refund on any grounds subject to management approval; the amount worth 25% for Administration Fees will be not be refunded.

The membership is not transferable to another name and cannot be frozen.

Membership fees shall be subjected to increase at the sole discretion of the Club. Juniors under the age of 2 years at the time of joining and included with a parent membership will be accepted with no charge. Couple memberships shall only apply to married couples. A non-refundable initiation fee will be paid at the time of joining. At the time of re-joining if the membership is not renewed at the end of the membership validity mentioned on the card. Should the membership not be renewed at the end of a term, the initiation fee shall apply at the time of rejoining. Football facility in not included as part of the membership. Applicable fees must be paid to book the Football ground. Body & Soul reserves the right to book the sports facilities for maintenance or related events. Rules & Regulations applicable for various sports facilities, swimming pool, gymnasium, aerobic classes and bookings apply to all memberships.

## CHILDREN/MINORS/NANNIES

- Teenagers / Children / Nannies must be accompanied by the member in the club at all times.
- Applicable membership fees apply for teenagers between 15 -18 years of age. A signed waiver along with Emirates I.D of the parent must be submitted by the member [Parent / Guardian] of the teenager.
- Children / Teenagers must attend the Junior Fitness Scholarship program with trainer before using the facility. Timings for using the gymnasium is between 6am -6pm.
- FULL membership fee / Daily Guest Pass fee of AED 50 is applicable for UNACCOMPANIED minors between 10 15 years of age.

Nannies accompanying children will be required to join under the Nanny category.

Juniors under 14 years must be accompanied by an adult at all times whilst at the club

**ACCESS CARDS** Access cards are mandatory to access the Health Club. Entry without access card is subject to verification of the member's details at the front desk.

Members are NOT allowed to use expired membership cards or enter using a friend or family's access card for entry. Guest fee of AED 70 per day will be applicable for members violating the club's access policy.

**PLATINUM** Platinum membership allows members the use of all Body & Soul Clubs.

**GENERAL** If accepted, the membership represents an agreement between the Member and Club that the member will abide by the Club rules and regulations set by the Club. Should any member abuse the rules in any way or act in any disrespectful way of other members or members of the staff team, the Club, at its sole discretion, reserves the right to cancel the members rights and privileges and access to any Body and Soul Health Club or Spa.

**LIABILITY AND WAIVER CLAIMS** The member and/or guardians of minors under the age of 18, agree that the facilities, services (including the Club grounds and packing) shall be used at the members own risk and the Club shall not be liable for any damage or injury to any members, or guest of a member, resulting from acts of active or passive negligence on the part of the Club, its owners, employees, officers or agents. It is expressly agreed that the Body and Soul Health Club shall not be responsible or liable to members or their guests for articles lost or stolen in the Club.
